#### From the Club's Constitution (The 85 rule, will be explained in the next Bulletin).

Section 3 — Excused Absences. A member's absence shall be excused if

(a) ... The Board may excuse a member's absence for reasons which it considers to be good and sufficient. Such excused absences shall not extend for longer than twelve months. However, if the leave is for a medical reason or after the birth, the adoption, or foster care of a child that extends for more than twelve months such leave may be renewed by the Board for a period of time beyond the original twelve months.

### Section 4 —

- (a) Attendance Percentages. A member must
  - (1) attend or make up at least 50 percent of Club regular meetings or satellite Club meetings, or engage in Club projects, other events and activities for at least 12 hours in each half of the year, or a proportionate combination of both;
  - (2) attend at least 30 percent of this Club's regular meetings or satellite Club meetings, or engage in Club projects, other events and activities in each half of the year ...
- (b) Consecutive Absences. ... each member who fails to attend or make up four consecutive regular meetings shall be informed by the Board that the member's non-attendance may be considered a request to terminate membership in this Club. ...
