PP Phil Brown and John Payne presented amendments which were not passed.


PP Wayne Fry had an amendment which was defeated.

The old Bylaws set out the specific date and time we should meet which was weekly at 6:00pm for 6:30pm.

The replacement Bylaw is new Bylaw, Article 5 Section 2 which gives the power in the Board to make a decision on the day, time and place of meetings and upon 21 days written notice, as a result the Board can now decide to meet fortnightly BUT the Club under the Constitution must meet at least two times per month.
